kindly refer to the above subject. In this regard it is mentioned that the ongoing Election process of the IP&TAFS Gr 'A' Officers Association for year 2020-22 is suspended due to the following reason.

The nominees of the following posts have withdrawn their nominations.

- 1) President ( There was alone nominee)
- 2) Executive Member (out of three nominees one nominee has withdrawn)

In this connection it is mentioned that as per the para 7 (b) of the constitution of the Association, the Executive Body of the Association shall consist of following office bearers all of which shall be directly elected by the members of an electoral college.

President (one), General Secretary (one), Secretary /Organization (one), Secretary/ Finance (one) & Executive Members (three).

Owing to the withdrawal of the candidature by two nominees the election process cannot be continued in view of the provisions of Bylaws mentioned above. As such the ongoing process of Election is suspended. The schedule for fresh process of the said Election will be issued soon.
